FMD LAUNCHES NEW WEBSITE AND OTHER UPDATES

Facilities Management (FMD) is excited to announce some recent changes we have made which will improve your experience. These changes include our new website, expanded hours for the service center and more. Please read below to find out all the new services FMD has to offer!

First, we launched a brand new **website** on August 19th. This improved website features a comprehensive list of services, our FY15 chargeable rates, the shuttle map and schedule, a calendar of events (including road closures and outages), custodial service levels and much more! The **Facilities Integrated Service Center** (FISC), which opened on May 5th, expanded its hours even more and is now open Monday to Saturday, 7 am to 7 pm as well as Sunday from 1 pm to 7 pm (except holidays). You can reach the FISC by calling 314-362-3100, emailing wusmfacilities@wusm.wustl.edu or visiting the first floor lobby of Olin Residence Hall. The FISC is here for all your facilities' needs, from custodial and maintenance to parking and badging.

Besides contacting the FISC, all students, faculty and staff can now access our online work order request system, **ServiceNow**, by visiting <https://wusm.service-now.com/myLogin.do>. Using your WUSTL key or computer login, you can submit work orders or view the status of a work order. We would also like to announce some improvements within **Facilities Engineering** and **Custodial Services**. In Engineering, we merged the Central, East and West shops into the East Shop and the West Shop, in order to align with Custodial Services' zones. We also combined the Electronic Shop and the Machine Shop. In Custodial Services, we accelerated the transition schedule from third shift to second shift since the process has gone so well. Earlier this year, Facilities Management, in collaboration with WUSM Human Resources, Barnes Jewish Hospital and St. Louis Children's Hospital, established the **Lactation Room Program**. We are pleased to announce there are now 26 lactation spaces available at the medical campus. These are new or recently renovated rooms that are available for faculty, staff, clinical fellows, postdoctoral appointees and medical students.
