Construction at Taylor Avenue Building – Temporary Parking Lot Closure

Starting on Monday, April 6th, we will begin tuck-pointing and caulking the Taylor Avenue Building (TAB). The workers will begin on the east side of the building, which will require the parking spaces in the Busch Lot to be temporarily closed while the work progresses around to the north side of the building along the MetroLink tracks.

The work along the MetroLink tracks is scheduled to begin around Monday, April 13th and the sidewalk along the north side of the building will be closed to pedestrian traffic while we work on this particular side of the building. As we advance around the building, we will provide an update of dates and times for the other areas that will need to be closed to allow the work to continue.

Simultaneously, starting on Monday, April 6th, we will begin to construct a parking area on the east side of TAB to help support new patient/visitor parking for Washington University School of Medicine Clinic Programs in TAB. We are anticipating this activity to last approximately two weeks.
